

POOL / SPA / HOT TUB POLICY

In any document originating from its website, Facebook Page or from on premise, or verbally over phone or on premise, these abbreviations and acronyms are to be considered the entity Beyond The Wall Bed and Breakfast LLC*

PLEASE Abide By All Posted Signs In The Pool Area

- Please Always Obey Florida State Law (Below)
- Talk To People, Make Friends
 - "So Where You From?"
 - "Come Here Often?"
 - "Do You Like Pancakes?"
 - Ask Fellow Guest To Have Dinner / Beers With You Downtown That Night
- Please Observe MANNERS / RESPECT / COURTESY Requirements At All Times
- **NO SMOKING** In Entire Pool Area
- **NO GLASS In The Pool Area – NEVER, NEVER EVER**
 - We Will NOT Be Polite About Violations Because This Is STUPID
 - Potential Damage Charges Could Occur

• **CHILDREN (*When Allowed*)**

- If Needed, Ensure Your Child Is A Wearing A Swim Diaper
 - If You Child Has An Accident, Then It Was "NEEDED"
 - If The Accident Creates A Public Health Event That Closes The Pool, A Damage Fee May Be Charged To Cover The Cost Of Getting The Pool Ready For Use Again
- Ensure Your Child Is Not Sick. Any Vomit Or Fecal Matter In The Pool Will Generate Damage Charges Up To And Including A Full Drain And Clean Of The Pool

- Screaming, Yelling, Running And Other General “Horseplay” Typical Of Adolescence Is Not The Atmosphere / Vibe That We Are Attempting To Create Here At Beyond The Wall Bed And Breakfast
 - We Strenuously Request - Do Not Allow This Behavior And Offend Our Other Guests
- No One Under 18 Years Old Is Allowed Near The Hot Tub / Spa Area To Include Being In The Actual Hot Tub / Spa
 - There Are Signs Stating That Guests Under The Age Of 18 Are NOT Welcome In Our Hot Tub / Spa

FLORIDA STATE LAW - Highlights Pertaining To Pools / Spas

POOL RULES

Section 64E-9.011(2): All Rules And Regulations Concerning Use Of The Public Swimming Pool

Must Be Posted In Minimum One Inch Letters Which Are Legible From The Pool Deck. The Posted Rules And Regulations Must Contain The Following, At A Minimum:

- (1). Food And Beverages Are Prohibited In The Pool And On The Pool Wet Deck Area*
- (2). Animals And Glass Containers Are Prohibited Within The Fenced Pool Area, Or 50 Feet From Pool Edge When No Fence Exists*
- (3). No Food Or Beverages In Pool Or On Pool Wet Deck.*
- (4). No Glass Or Animals In The Fenced Pool Area (Or 50 Feet From Unfenced Pool)*
- (5). Bathing Load: ___ Persons.*
- (6). Pool Hours: ___ A.M. To ___ P.M.*
- (7). Shower Before Entering.*
- (8). Children Under Twelve Must Have Adult Supervision.*
- (9). Pregnant Women, Small Children, People With Health Problems And People Using Alcohol, Narcotics Or Other Drugs That Cause Drowsiness Should Not Use Spa Pools Without First Consulting A Doctor. (See S-7597 & S-3501)*

SPA RULES

Spa Pool Signs Must Include The Following:

- (A) Maximum Water Temperature 104 (Degrees) F*
- (B) Children Under Twelve Must Have Adult Supervision*
- (C) Pregnant Women, Small Children, People With Health Problems And People Using Alcohol, Narcotics Or Other Drugs That Cause Drowsiness Should Not Use Spa Pools Without First Consulting A Doctor*
- (D) Maximum Use 15 Minutes. (See S-7638)*

SPA ALARM SIGN

The Following Additional Rule Sign Must Be Visible By The Spa Which Reads "ALARM INDICATES SPA PUMPS OFF

DO NOT USE SPA WHEN ALARM SOUNDS UNTIL ADVISED OTHERWISE." (See S-7768)
